

D.C. LAW 5-39

"Farmers' Street Market Space Charge Increase
Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-97 on first and second readings, July 5, 1983 and September 6, 1983, respectively. Following the signature of the Mayor on September 22, 1983, this legislation was assigned Act No. 5-64, published in the September 30, 1983 edition of the D.C. Register, (Vol. 30 page 4991) and transmitted to Congress September 26, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-39, effective November 15, 1983.

D.C. ACT 5 - 64

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

SEP 22 1983

To increase the charge for use of space at certain farmers' street markets in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Farmers' Street Market Space Charge Increase Act of 1983".

Sec. 2. The second subparagraph of the paragraph entitled "FOR MARKET MASTERS" contained in the section designated as "GENERAL EXPENSES." in An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and seven, and for other purposes, approved June 27, 1906 (34 Stat. 485; D.C. Code, sec. 10-138), is amended by striking the following sentence "And the Commissioners are hereby authorized to make such reasonable charges for the use of space at the above-mentioned street markets as may be deemed just, but in no case shall the collections for such space and for labor, and the sweeping, cleaning, and hauling away of refuse at such space exceed the sum of twenty cents per day for each space occupied, and the market masters of the several markets herein mentioned shall make such collections daily and make a return thereof, with a sworn statement, weekly to

the sealer of weights and measures, who shall deposit the same with the collector of taxes to the credit of the revenues of the District of Columbia." and inserting the following sentences "There is hereby authorized for the use of space at the above-mentioned street markets a space charge of one dollar per day for each space occupied for rent. The market masters of the several markets herein mentioned shall make collections daily and make a return thereof, with a sworn statement, weekly to the sealer of weights and measures, who shall deposit the same with the Mayor to the credit of the revenues of the District of Columbia.


"The Mayor of the District of Columbia shall amend by rule from time to time the charge imposed for the use of space at the street markets mentioned in this Act." in lieu thereof.


Sec. 3. Section 2 shall take effect 30 days following the effective date of this act.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec.
