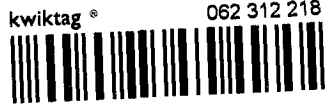

NOTICE

D.C. LAW 10-121

"Public Utility Environmental Impact Statement
Electrical Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-284 on first and second readings, February 1, 1994, and March 1, 1994, respectively. This legislation was deemed approved without the signature of the Mayor on March 21, 1994, this legislation was assigned Act No. 10-212, and published in the April 1, 1994, edition of the D.C. Register (Vol. 41 page 1653) and transmitted to Congress on March 24, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-121, effective May 21, 1994.

District of Columbia Code

D.C. ACT 10-212

(1994 Supplement)

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 21, 1994

To amend the District of Columbia Public Utility Environmental Impact Statement Requirement Act of 1989 to require an environmental impact statement for the installation, repair, or replacement of an electric generating facility or overhead transmission line of 69,000 volts or more.


BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public Utility Environmental Impact Statement Electrical Amendment Act of 1994".

Sec. 2. Section 3(1)(H) of the District of Columbia Public Utility Environmental Impact Statement Requirement Act of 1989, effective October 19, 1989 (D.C. Law 8-45; D.C. Code § 43-1902(1)(H)), is amended by striking the phrase "over 69,000 volts" and inserting the phrase "69,000 volts and over" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District

of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
