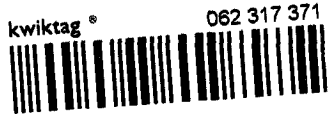

**D.C. LAW 11-49**

**"District of Columbia Board of Education Fees for Adult,  
Community, and Continuing Education Courses  
Temporary Amendment Act of 1995".**

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-309 on first and second readings, June 6, 1995 and June 20, 1995, respectively. Following the signature of the Mayor on July 6, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-91 and published in the July 14, 1995, edition of the D.C. Register (Vol. 42 page 3632) and transmitted to Congress on July 11, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-49, effective September 20, 1995.

AN ACT  
D.C. ACT 11-91

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA  
JULY 6, 1995

To authorize, on a temporary basis, the District of Columbia Board of Education to charge fees for all adult, community, and continuing education courses.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this act may be cited as the "District of Columbia Board of Education Fees for Adult, Community, and Continuing Education Courses Temporary Amendment Act of 1995".

Sec. 2. The District of Columbia Board of Education Fees for Select Adult, Community, and Continuing Education Courses Act of 1994, effective March 16, 1995 (D.C. Law 10-221; 41 DCR 8047) is amended as follows:

- (a) Section 2 (D.C. Code § 31-131) is repealed.
- (b) Section 3 (D.C. Code § 31-132) is amended as follows:
  - (1) By amending subsection (a) to read as follows:

"(a) The District of Columbia Board of Education ("Board of Education") is authorized to charge fees for all adult, community, and continuing education courses; provided that no additional fees shall be charged for ongoing courses in Academic Year 1994-1995 and Fiscal Year 1995 until those courses are completed.";

(2) By amending subsections (b), (c), (d), and (e) by striking the word "select" wherever it appears; and

(3) By amending subsection (d) by striking the phrase "fiscal year 1995 Supplemental Budget" and inserting the phrase "Annual Budget Request Act" in its place.



Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor ( or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24,



(b) This act shall expire after 225 days of its having taken effect or upon the effective date of the District of Columbia Board of Education Fees for Adult, Community, and Continuing Education Courses Amendment Act of 1995, whichever occurs first.
