IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

---

To amend the District of Columbia Retirement Reform Act to permit a member selected to serve an unexpired term of one year or less to serve the remaining portion of the unexpired term and a subsequent 4-year term, and to eliminate term limits for the members.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Retirement Reform Amendment Act of 2000".

Sec. 2. The District of Columbia Retirement Reform Act is amended as follows:

(a) Section 102 is amended by adding a new paragraph (6A) to read as follows:

"(6A) The term "good cause" means board members not attending more than half of the scheduled board meetings in a 12 month period."

(b) Section 121(b) is amended as follows:

(1) Paragraph (3) is amended to read as follows:

"(3)(A) Members of the Board shall each serve a term of 4 years, except that a member selected to fill a vacancy occurring prior to the end of the term for which his predecessor was selected shall only serve until the end of such term. If the portion of the remaining term to be filled is one year or less, the member selected to fill the vacancy shall serve until the end of such term and shall serve a subsequent 4-year term. A member may serve after the expiration of his term until his successor has taken office.

"(B) A vote of two-thirds of the members of the Board shall remove any Board member from office for good cause, after notice to the Board member."

(2) Paragraph (4) is repealed.

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Authority Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District in Columbia Register.
