D.C. LAW 4-102 .

"District of Columbia Workers' Compensation Act  
of 1979 Amendments Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-314 on first and second readings, February 9, 1982 and February 23, 1982, respectively. Following the signature of the Mayor on February 26, 1982, this legislation was assigned Act No. 4-161, published in the March 19, 1982 edition of the D.C. Register, (Vol. 29 page 1179) and transmitted to Congress on March 5, 1982 for a 30-day review, in accordance with Section 502 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-102, effective April 22, 1982.

D.C. ACT 4-161

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

FEB 26 1982

To amend the District of Columbia Workers' Compensation Act of 1979.


BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,  
That this act may be cited as the "District of Columbia Workers' Compensation Act of 1979 Amendments Act of 1982".

Sec. 2. Section 47 of the District of Columbia Workers' Compensation Act of 1979, effective July 1, 1980 (D.C. Law 3-77) is amended by striking the phrase "October 1, 1981" and inserting the phrase "60 days after the expiration of the District of Columbia Workers' Compensation Act Emergency Amendment Act of 1982" in lieu thereof.


Sec. 3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved

December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
