Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-147 on first and second readings, May 5, 1981 and May 19, 1981, respectively. Following the signature of the Mayor on June 5, 1981, this legislation was assigned Act No. 4-44, published in the June 12, 1981 edition of the D.C. Register, (Vol. 28 page 2616) and transmitted to Congress on June 11, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-23, effective August 1, 1981.

To amend the District of Columbia Campaign Finance Reform and Conflict of Interest Act to clarify its provisions concerning persons required to file Financial Disclosure Statements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "Financial

Disclosure Statement Clarification Amendments of

1981".

Sec. 2. Section 602(a) of the District of Columbia Campaign Finance Reform and Conflict of Interest Act. approved August 14. 1974 (88 Stat. 467; D.C. Code. sec. 1-1182(a)) is amended by deleting the phrase "appointed under the authority of title X or sections 901 - 903 (and paid at a rate of a GS-13 or above in the General Schedule or comparable compensation under title XI of the District of Columbia Government Comprehensive Merit Personnel Act of 1978)" and inserting the

phrase "serving as subordinate agency heads or serving in positions designated as within the Excepted Service (regardless of date of appointment) and paid at a rate of DS-13 or above in lieu thereof.

Sec. 3. This act snall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
