"District of Columbia Documents Act Amendment of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-266 on first and second readings, July 1, 1981 and July 14, 1981, respectively. Following the signature of the Mayor on July 23, 1981, this legislation was assigned Act No. 4-70, published in the July 31, 1981 edition of the D.C. Register, (Vol. 28 page 3423) and transmitted to Congress on July 29, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-41, effective . October 17, 1981.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "District of

Columbia Documents act amendment of 1981".

Sec. 2. Section 308(a) of the District of Columbia Administrative Procedure Act. effective March 6. 1979 (D.C. Law 2-153; D.C. Code. sec. 1-1538(a)) is amended by striking the phrase "July 1. 1981" and inserting the phrase "December 31. 1982" in lieu thereof.
