D.C. LAW 4-82

"Motor Vehicle Inspection Fee Cost Recovery Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-302 on first and second readings, November 24, 1981 and December 8, 1981, respectively. Following the signature of the Mayor on December 21, 1981, this legislation was assigned Act No. 4-136, published in the January 8, 1982 edition of the D.C. Register, (Vol. 29 page 159) and transmitted to Congress on January 11, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-82, effective March 16, 1982.

DEG 2 1 1981

To provide for an increase in fees for the annual inspection of motor vehicles in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Motor Vehicle Inspection Fee Cost Recovery Act of 1981".

Sec. 2. Section 1 of An Act to provide for the annual inspection of all motor vehicles in the District of Columbia, approved October 31, 1969 (52 Stat. 78; D.C. Code, sec. 40-201) is amended by striking the figure "\$3" and inserting the figure "\$5" in lieu thereof.

Code,
