"First Source Employment Agreement Act of 1984 Amendments Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-542 on first and second readings, December 4, 1984 and December 18, 1984, respectively. Following the signature of the Mayor on January 11, 1985, this legislation was assigned Act No. 5-240, published in the February 8, 1985 edition of the D.C. Register, (Vol. 32 page 746) and transmitted to Congress January 23, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-175, effective March 15, 1985.

To amend the First Source Employment Agreement Act of 1984 to include leasing agreements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "First Source Employment

Agreement Act of 1984 Amendments Act of 1984".

Sec. 2. Section 2 of the First Source Employment
Agreement Act of 1984, effective June 29, 1984 (D.C. Law
5-93; D.C. Code. sec. 1-1161 (1985 supp.)), is amended as
follows:

- (a) Paragraph (1) is amended to read as follows:
- "(1) 'Beneficiary' means the signator to a contract executed by the Mayor which involves any District of Columbia government funds, or funds which, in accordance with a federal grant or otherwise, the District of Columbia government administers, and which details the number and description of each entry-level job created by a government-assisted project, including leasing agreements of real property of one year or more, for which the beneficiary is required to use the First Source Register.".
 - (b) Paragraph (5) is amended to read as follows:
 - "(5) 'Government-assisted project' means any

project funded in whole or in part with District of Columbia funds, or funds which, in accordance with a federal grant or otherwise, the District of Columbia government administers, and on which the District of Columbia is signatory to any agreement of a contractural nature, including leasing agreements of real property for one year or more.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in event of veto by the Mayor, action by the .Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1).
