D.C. LAW 6-106

"District of Columbia Public Assistance Payments Increase Temporary Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-366 on first and second readings, January 14, 1986, and January 28, 1986, respectively. This legislation was deemed approved without the signature of the Mayor on February 14, 1986, pursuant to Section 404(e) of "the Act", and was assigned Act No. 6-135, published in the February 28, 1986, edition of the D.C. Register, (Vol. 33 page 1165) and transmitted to Congress on February 19, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-106, effective April 11, 1986.

D.C. ACT 6 - 135

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

FEB 1 4 1986

To amend, on an temporary basis, section 552 of the District of Columbia Public Assistance Act of 1982 to increase the payment levels and standards of assistance for recipients of public assistance.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public Assistance Payments Increase Temporary Act of 1986".

- Sec. 2. Section 552 of the District of Columbia Public Assistance Act of 1982, effective April 6, 1982 (D.C. Law 4-101; D.C. Code, sec. 3-205.52), is amended as follows:
- (1) Subsection (d) is amended by striking the words "this section" and inserting in its place "subsection (c) of this section" and by striking the period and adding the phrase "through March 31, 1986.".
- (2) New subsections (e) and (f) are added to read as follow:
- "(e) The standards of assistance, based on the February 1985 cost of living index, are set forth in the following table and include basic costs of food, clothing,

D.C. Code, sec. 3-205.5 (1987 supp.) shelter, household and personal items, certain transportation costs, and life insurance when paid by the Mayor.

"(f) The table set forth in subsection (e) of this section shall be used for all payments and eligibility determinations made after March 31, 1986.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
