D.C. LAW 6-54

"Motor Vehicle Special Use Certificates and Tags Validity Period Extension Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-201 on first and second readings, September 10, 1985, and September 24, 1985, respectively. Following the signature of the Mayor on September 30, 1985, this legislation was assigned Act No. 6-77, published in the October 11, 1985, edition of the D.C. Register, (Vol. 32 page 5713) and transmitted to Congress on October 3, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-54, effective November 19, 1985.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the District of Columbia Revenue Act of 1937 to extend the validity period for motor vehicle special use certificates and special use identification tags.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Motor Vehicle Special Use Certificates and Tags Validity Period Extension Amendment Act of 1985".

- Sec. 2. Section 2(d)(5)(A) of title 4 of the District of Columbia Revenue Act of 1937, effective March 10, 1983 (D.C. Law 4-206; D.C. Code, sec. 40-102(d)(5)(A)), is amended by striking the word "twenty" and inserting the word "thirty" in its place.
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
