

D.C. LAW 8-71

"District of Columbia Public School Firearm Prohibition Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-240 on first and second readings, October 10, 1989, and October 24, 1989, respectively. Following the signature of the Mayor on November 2, 1989, this legislation was assigned Act No. 8-108, published in the November 10, 1989, edition of the D.C. Register, (Vol. 36 page 7746) and transmitted to Congress on November 6, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-71, effective February 27, 1990.

AN ACT

D.C. ACT 8 - 10 8

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 0 2 1989

To amend section 16-2307 of the District of Columbia Code to specify that a person under the age of 18 years charged with the possession of a firearm in or within 500 feet of a public school building or property or a public school sponsored event may be charged as an adult.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public School Firearm Prohibition Act of 1989".


Sec. 2. Section 16-2307(a) of the District of Columbia Code is amended as follows:


Section  
16-2307

- (a) By striking "or" in paragraph (2);
- (b) By striking the "." at the end of paragraph (3) and inserting the phrase "; or" in its place; and
- (c) By adding a new paragraph (4) to read as follows:  
"(4) a child under the age of 18 years is charged with the illegal possession or control of a firearm in or within 500 feet of a District of Columbia public school building, public school property, or a public school-sponsored event."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal  
Regulations.




