
NOTICE

D.C. LAW 9-93

"Education in Partnership with Technology
Corporation Establishment Act of 1986
Capitalization Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-239 on first and second readings, January 7, 1992, and February 4, 1992, respectively. Following the signature of the Mayor on February 21, 1992, this legislation was assigned Act No. 9-161, published in the March 6, 1992, edition of the D.C. Register, (Vol. 39 page 1371) and transmitted to Congress on February 26, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-93, effective April 8, 1992.


To amend the Education in Partnership with Technology Corporation Establishment Act of 1986 to allow certain donations from private sources to be treated as contributions to capitalization.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Education in Partnership with Technology Corporation Establishment Act of 1986 Capitalization Amendment Act of 1992".

Sec. 2. Section 9(4) of the Education in Partnership with Technology Corporation Establishment Act of 1986, effective February 24, 1987 (D.C. Law 6-170; D.C. Code §31-2508(4)), is amended by adding the phrase "of equipment, or in-kind services, or other cash or non-cash contributions" after the phrase "a commitment for funding". Section 31-2508

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
